

Short News Indefinite strike of **RTO employees union** suspended KALYAN, PRAMOD KUMAR:

The RTO Employees' Association had started an indefinite strike from September 24 to meet the basic demands of the employees. All the demands were discussed positively in the Transport Commissioner's office on Thursday . In this discussion, as per the demand of the organization , the entry rules for senior clerk to office superintendent posts will be finalized by 30th November 2024. A clear assurance was given that the eligible employees will be promoted ad hoc till then. The policy of making transfers according to revenue department has been canceled and it has been agreed to make transfers within 15 departments as before. The administration also agreed to take positive decisions on other demands. Accordingly, the indefinite strike has been suspended. On behalf of the organization, General Secretary SurendraSaratape expressed his gratitude by giving a bouquet of flowers as the administration has accepted the sincere demands of the employees, and expressed his hope for similar cooperation.

Rahul Gandhi Over Farmers' Issue In Haryana

Maharashtra Deputy Chief Minister DevendraFadnavis on Friday blamed "fake narrative" by the Opposition and "vote jihad" for the BharatiyaJanata Party's (BJP) poor show in the recent LokSabha elections, adding that the issues have been fixed and the "ground reality is different" ahead of the state Assembly elections. Speaking at Town Hall, Fadnavis said, "In the LokSabha election results, BJP-led Mahayuti's vote share was 43.6%, while the opposition's Maha Vikas Aghadi (MVA) secured 43.9%. While the difference was small, it had a impact on the number of maior seats." Elaborating further, he said, "The fake narrative of the changing of the Constitution and reservation percolated. We saw a vote jihad in Maharashtra. In DhuleLokSabha seat, in five of the six assembly seats, we were ahead by 1.9 lakh votes. In Malegaon Madhya, we lost by 1,94,000, a gap of 4,000 votes. The CM himself has been facing demands to step down after a trial court ordered filing of charges in connection with the alleged Mysuru Urban Development Authority, or MUDA, land scam."Why should she resign if the electoral bond funds didn't go into her personal account? They've asked for an FIR to be filed, but that doesn't mean she is guilty," Kumaraswamy said.

term (2022-23 to 2027-28), was removed from his role on 31st May 2024 following a complaint alleging he breached the Maharashtra Co-operative Societies Act, which disgualifies members with more than two children. After his appeal to the Deputy Registrar and Divisional Joint Registrar was dismissed, he took his fight to the Bombay High Court.

Adv. Manoj Jaiswal, representing Mr. Zore, argued vigorously that the disqualification was not only unfair but also legally unsound. He pointed out that the Maharashtra Co-operative Societies Act specifically exempts housing societies from the application of Section 73CA(1)(vii). He further highlighted that the disqualification infringed upon Mr. Zore's fundamental rights under Articles 14 and 21 of the Constitution, branding the orders as arbitrary and a blatant disregard for natural justice.

After a comprehensive hearing on 27th September 2024 Justice R. M. Joshi recognized the merits of Mr. Zore's case and granted a stay on the disqualification until 19th November 2024. This decision provides temporary relief for Mr. Zore and shines a spotlight on the broader implications of the case, raising questions about how the law is applied to co-operative societies and their members.

State-of-the-art system ready for composting from waste of societies

Launched at Godrej Emerald Society in Ghodbunder



Thane, (Representative):

Under the Swachh Bharat Abhivan of the Government of India, orders have now been given to the local self-government bodies that the waste in the society should be disposed of by the society itself. Therefore, now most of the societies have started their own waste collection centers and a sophisticated composting system has been installed in Emerald Society on Ghodbunder Road in Thane. Every day 1 ton of fertilizer is being produced from this project and this fertilizer is being used in pots by the societies. Godrej Emerald, a society in Ghodbunder, has taken a positive step to stop environmental degradation by purchasing this project. The project is being handled by the company Amalgus and the residents of GoudrejErold believe that other societies in the vicinity can benefit from this scheme. A waste-towaste composting project has recently been installed at Godrej Emerald Society in Thane. Due to the efforts of Godrej Emerald Society President Dadasaheb Gawli, Secretary Yogesh Chaudhary, Treasurer TejinderWahi, efforts were made to dispose of the waste in the society and make fertilizer Ram Achal, who was working | from it. Accordingly, this project has been successfully



launched by implementing the staff system in the waste to fertilizer production system through AkshayKoli'sAmalgus Company.In order to participate in the cleanliness campaign of the Government of India, a state-of-the-art system is being maintained through the company Amalgoos to collect the waste from the society, prepare fertilizer from it and use it for the trees in the society to protect the environment. It was launched recently. From this waste, 1 tonne of waste per day is collected and processed in the composting plant. The workers working on this project are carrying out this process using even safety equipment to separate the plastic and other unnecessary components from the waste and include the material required for the fertilizer project.Apart from the society, the fertilizer produced in this fertilizer project is also supplied to the trees planted on both sides of the road by the Thane Municipal Corporation. AkshayKoli, manager of Amalgus, expressed optimism that if other societies in Thane also start this project in their societies, the problem of waste disposal will be solved and the pressure on the dumping grounds outside the city will be reduced.

On Saturday morning, the body of an 18-year-old girl was found hanging from a noose in a room on the second floor of Jeevan Pratima Clinic located at MullaTalab on Station Road in Bhadohi local Kotwali area under suspicious circumstances. Police reached the spot as soon as they received the information and after investigation, took the body in their custody and sent it for postmortem.Uday Shankar Saroj, a resident of DudwaKukrauthi village of Kotwali area, works in Mumbai. While his wife Sumitra Devi lives with her three daughters on the second floor of JeevanPratima Clinic located on Station Road MullaTalab in the city. She also works in the same clinic. In the morning, the sound of crying was coming from inside the clinic. When people passing



by went inside and looked, they understood the matter. The police was informed about it. The body of the girl was hanging from a noose in the room. While her feet were touching the

ground. However, after seeing it, the matter seemed suspicious. However, as soon as the incident was known, a huge crowd gathered at the spot. As it was a few steps away from the police

station, Inspector-in-charge Ashwan Kumar Tripathi reached the spot with his companions. The police reached the spot and started investigating. Meanwhile, the area officer Ajay Kumar Chauhan also reached the spot. The police took the body into custody and sent it for post-mortem. This will become clear in the police investigation. However, after the incident, the deceased's mother Sumitra Devi and her two younger sisters Radhika and Sarmadhi were inconsolable and kept crying. The police have informed the deceased's father, who lives in Mumbai, about the incident.

UP Sets Up Special Squad Amid Adulteration Complaints to Ensure Restaurants Serve Hygienic Food

Lucknow, Ashok Singh:

A special squad of the Food Safety and Drug Administration (FSDA), UP Police, and administrative officers will now ensure that only hygienically prepared food is served in Uttar Pradesh's restaurants. The squad will also make sure that the details of the food and names of the restaurant/ eatery owner are displayed in bold and the food is prepared and served under CCTV surveillance. The move is part of the UP government's latest food-safety guidelines introduced to curb incidents of food adulteration. The fresh guidelines were welcomed by UP's restaurateurs and eatery owners, who are now preparing to implement the new rules.Of late, the state has witnessed a spurt in instances where human waste, including saliva and urine, was mixed with food and served. Officials with the UP government said it was the recent instances which



prompted the state government to set fresh guidelines regarding preparation and serving of food."Recent reports from across the country have revealed cases of food items such as juice, dal, and roti being adulterated with human waste. inedible, or filthy substances. These actions are atrocious and pose a grave threat to public health," a UP government statement said while quoting UP Chief Minister Yogi

Adityanath, who recently held a highmeeting with top-level profile government officials, including from the FSDA."Such malicious practices are completely unacceptable. And to prevent such occurrences in UP, concrete measures must be put in place to ensure food safety and protect the health of the common man," the chief minister said.Recently, a juice vendor in Ghaziabad was arrested on

charges of mixing urine in the juices he served. Similarly, on September 12, a video showing a teenager spitting on rotis while preparing them at an eatery in Saharanpur district went viral on social media, leading to the arrest of the facility's owner.Referring to such incidents, the UP CM also gave instructions for a thorough investigation and verification of all hotels, dhabas, restaurants, and related establishments in the state. Besides, the CM has also given instructions to amend the rules as per the need while ensuring the safety of the general public. "Dhabas, restaurants, and food establishments should be thoroughly inspected, with police verification of all employees. Necessary amendments should also be made to the Food Safety and Standards Act to ensure the purity and sanctity of food items," the statement further stated.

MUDA Scam: Special Court Directs Probe Against Karnataka CM Siddaramaiah, Report Due in Three Months

special court in Karnataka on Wednesday (September 25) has directed the Mysurulokayukta police to investigate chief minister Siddaramaiah, his wife B.M. Parvathi, and others in connection with the alleged Mysore Urban Development Authority (MUDA) scam and submit a report within three months. The investigation order comes a day after the Karnataka high court dismissed Siddaramaiah's petition challenging the governor's approval for an investigation into the site allotment case.Reacting to the special court for elected representatives' directive today, Siddaramaiah wrote on X, "I am ready to face the investigation and continue the legal fight. As I said yesterday, I repeat today: there is no question of fearing an investigation; I am determined to face everything. After discussing with legal experts, I will decide the next course of action."The controversy revolves around the allocation of compensatory sites to Parvathi by MUDA in a prime locality in Mysuru. The sites were allocated under a 50:50 ratio scheme in exchange for 3.16 acres of land, which was supposedly developed into a residential layout. However, allegations suggest that Parvathi did not hold legal title to the 3.16-acre land in question. Activist Snehamayi Krishna filed a private complaint, raising concerns about the legality of the site allotment process.The investigation will examine the allegations of improper site allocation, undervalued land exchange, and questionable land ownership."The decision of the governor of alleged hot haste has not vitiated the order, the order is restrictive to approval under Section 17A of the Act and not an order granting sanction under 218 of BNSS," the high court had mentioned in its order on Tuesday, as per Live Law.Section 17A allows for inquiry or investigation into offences related to decisions made by public servants in their official capacity. The development has sparked a political row in Karnataka, with Opposition parties demanding Siddaramaiah's resignation."Over the last year and a half that Siddaramaiah has been the chief minister there have been many many instances of public money being looted... Rahul Gandhi should do a press conference on the land scam and corruption scam that's going on in his party... He should answer why does it happen that leaders of the Congress party loot the money and assets that is meant for the poor. When will they put a halt to this?" BharativaJanata Party (BJP) leader Rajeev Chandrasekhar said in a press conference on Tuesday. The Congress party has accused the governor of bias, claiming he has not acted on other pending cases."The court has explicitly dismissed the prosecution sanction under Section 218 of the BNSS Act. In due course, the investigation permitted under Section 17(A) will also be reveal your false allegations," Karnataka minister PriyankKharge said post the high court order on luesday. Similarly, deputy chief minister D.K. Shivakumar mentioned that the Congress party stands firmly behind the chief minister. Did Tirupati Devotees Consume Non-Vegetarian Laddus?

DINESH SINGH : ince Andhra Pradesh chief minister N. Chandrababu Naidu alleged on September 18 that animal fat was used in preparing the famous Tirupatiladdu during Jagan Mohan Reddy's time in government, a burning question has emerged: Did crores of devotees unknowingly consume non-vegetarian laddus?The allegation sent shockwaves through the devotee community, raising both spiritual and health concerns. Neither the NDA government nor the TirumalaTirupatiDevasthanams (TTD), the trust managing the temple, has provided a satisfactory answer to this pressing concern. This convenient equivocation has sparked widespread confusion in traditional and digital media, particularly on social platforms where misleading and concerted communal narratives are being actively propagated, fuelled by the Hindutva ecosystem. Circulating images of unverified lab reports, purportedly proving the use of animal fat in the ghee for laddu preparation, have lent several questionable narratives a veneer of scientific legitimacy. Despite this, dairy scientists have independently clarified that the fatty acid profile is more consistent with plant or vegetable oils. Furthermore, the show cause notice issued to AR Dairy Food Private Limited only alleges adulteration with plant-based oils, citing the presence of β-sitosterol - a plant sterol - rather than animal fats.

TTD's conflicting press conferences

Two separate press conferences by the TTD executive officer referenced the same National Dairy Development Board CALF report, which revealed ghee adulteration with plant-based oils rather than animal fats. CALF is the Centre for Analysis and learning in Livestock and Food.However, executive officer J. ShyamalaRao drew different inferences from the report in each conference initially identifying vegetable fat adulteration, but later citing dangerously low 'S' values suggestive of animal fats. Dairy scientists clarified that the fatty acid profile was more consistent with plant oils like coconut and palm oil. Meanwhile, ghee traders confirmed that plant-based adulteration is common, as cheaper oils are often used to cut costs, making animal fat adulteration unlikely. On July 24, J. ShyamalaRao held a press conference to address concerns about the laddu's guality. He revealed that an National Accreditation Board for Testing and Calibration Laboratories (NABL) test had uncovered one supplier providing ghee adulterated with vegetable fat. As a result, one of the five suppliers was blacklisted for failing to meet quality standards. Action was taken against another company, with show cause notices issued to two suppliers in total.At the same press conference. Rao acknowledged that TTD currently lacks a device for testing ghee quality, though plans are in motion to acquire one soon. He highlighted ongoing challenges in procuring raw materials and ghee for the ladduprasadam. To bolster quality control, TTD has formed a committee of dairy experts - dubbed the "Ghee Committee" - comprising Dr.Mahadevan from Bengaluru, Dr.Surendranath, Dr.VijavaBhaskar Reddy from Hyderabad, and professor SwarnaLatha. This committee's primary task will be to assess the ghee's quality, with a particular focus on its aroma and overall integrity. Lab tests revealed significant adulteration, but rather than animal fats, the tests suggested the use of cheaper vegetable oils, complicating Naidu's allegation. On September 20, J. ShvamalaRao held another press conference two days after Naidu's allegations about the quality of ghee supplied to the temple. Following complaints about the poor quality of laddus, TTD had sent ghee samples to the NDDB in Guiarat for analysis. The results revealed that four out of 10 tankers from Tamil Nadu-based AR Dairy Food Private Limited - one of TTD's five contracted suppliers - were highly adulterated. This led to the rejection of these shipments and the blacklisting of the supplier.Citing the NDDB report, Rao highlighted that the ghee's 'S' value - a key quality indicator - was alarmingly low at 19.72, far below the required standard of 98.68 to 104.32 indicating it contained dangerously high levels of foreign fats, including fish oil, beef tallow, and lard, as revealed by the lab tests.

Analysing fatty acid profiles and adulteration claims

Interestingly, the NABL report Rao referenced in the July 24 press conference is the same NDDB-CALF report he mentioned in the September 20 press conference. The NABL is India's primary



The Wire has obtained access to this five-page NDDB-CALF report (plus annexure). The report details the results of a chemical analysis conducted by NDDB CALF Ltd, on a ghee sample labelled "TN02BB 2070". The analysis revealed key findings about the ghee's fatty acid composition and adulteration tests, marked with # in the report. The Free Fatty Acid (Oleic Acid) level was 0.440%, well below the FSSAI maximum limit of 2.000%. Milk Fat content measured 99.618%, surpassing the minimum requirement of 99.500% set by IS 3509:1966. The ButvroRefractometer reading of 43.400 fell within the acceptable range of 40.000-44.000. Adulteration tests yielded negative results for both the Baudouin Test (no sesame oil detected) and the Mineral Oil Test (no mineral oil contamination found). However, the analysis identified several fatty acids outside the specified ranges: Lauric Acid at 11.713% (permissible range: 1.500-4.000%), Palmitic Acid at 39.462% (exceeding the 38.000% upper limit), and Linoleic Acid at 5.538% (acceptable range: 0.500-3.500%). Other parameters showed a Moisture Content of 0.124%, well within the maximum limit of 0.500%. The Saponification Value of 241.952 exceeded the specified maximum of 235.000, suggesting the presence of fats with lower molecular weights than expected.

Understanding ghee composition and adulteration

A dairy scientist based in Canada, speaking to The Wire on condition of anonymity, confirmed that analysing the fatty acid profile can help assess the possibility of ghee adulteration with animal fat. "While animal fats, particularly beef tallow or pork lard, have distinct fatty acid compositions, the report does not provide conclusive evidence to either confirm or rule out this type of adulteration," she said.Expanding on the report's inconclusive findings, she explained, "Lauric acid, commonly found in tropical oils like coconut oil, was detected in high amounts, making plant oils a more likely adulterant than animal fats. Similarly, palmitic acid, which is common in both dairy and animal fats, exceeded the permissible limit. However, this alone does not specifically indicate animal fat adulteration, as palmitic acid could come from either source."She further explained, "Ghee, derived from cow's milk, is rich in short-chain fatty acids like butyric acid. The report shows that butyric acid was below the limit of quantification (LOQ), which could raise suspicions. However, if animal fats were present, we would expect to see more significant differences in other key fatty acids, such as stearic and oleic acids." "These two fatty acids are common in both animal and dairy fats. Stearic acid at 9.614% is within the expected range for ghee (8.000-19.000%), which suggests there is not a high amount of animal fat, as tallow and lard have higher stearic acid content. Oleic acid at 26.302% also falls within the expected range for ghee (19.000-32.000%).""The Reichert-Meissl Value (RM) is 29.010, well above the minimum limit of 24.000. While a low RM value could indicate the presence of non-dairy fats. such as animal fats, the high RM value here suggests that the sample contains a significant amount of dairy fat. The Polenske Value is 1.700, within the range of 0.500-2.000. This value helps distinguish animal fats from dairy fats, and the result does not raise any red flags for animal fat adulteration."

Show Cause Notice: Allegations of Plant-Based Adulteration

The Wire also obtained access to the show cause notice issued by the TTD to AR Dairy Food Private Limited on July 27. The notice cites the lab test report from NDDB CALF Ltd. dated July 23, 2024. The show cause notice does not accuse AR Dairy of adding animal fats to the ghee. Rather, it alleges adulteration with plant-based oils, citing the presence of β -sitosterol – a plant sterol. This evidence points to the addition of vegetable fats, not animal fats. The abnormalities in the fatty acid profile, particularly the high levels of Lauric and Linoleic Acids, also align with the use of vegetable oils such as coconut or palm oil, rather than animal fats. The show cause notice raises objections on three parameters: saponification value, presence of β -sitosterol, and milk fat purity. "The saponification value of 249.644, which is outside the permissible

range, suggests the presence of non-milk or foreign fats, indicating adulteration. Additionally, the high ß-sitosterol value of 167.895 mg/kg, which should be absent in pure cow ghee, strongly indicates possible adulteration with vegetable oils, as β -sitosterol is a plant sterol commonly found in plant oils," VelugotiPadmanabha Reddy told The Wire. Reddy is the vice-chancellor of Sri Venkateswara Veterinary University, Tirupati, and a distinguished veterinarian, and renowned dairy and food safety researcher with over 35 years of multidisciplinary professional experience. He emphasised that the milk fat content was 99.618%, exceeding the required 99.5%. "Achieving 100% purity is virtually impossible," he explained. "The standard for ghee is 99.5% milk fat, with the remaining 0.5%allowance for moisture and vitamins. In this case, the moisture content was a mere 0.124% well below the permitted 0.5% - a clear indicator of good quality in that aspect."The show cause notice clearly does not accuse AR Dairy Food Private Limited of adding animal fats to the ghee. Rather, it alleges adulteration with plant-based oils, citing the presence of β -sitosterol – a plant sterol. This evidence points to the addition of vegetable fats, not animal fats. When asked about EO SyamalaRao's claim that the ghee's 'S' value was dangerously low at 19.72, Reddy explained that these values come from highly sophisticated tests. "The fatty acid test is extremely complex and typically reserved for research, not routine analysis. It's also quite expensive," he noted. "The 'S value' actually refers to the separation value. In chromatography, when you have a sample with, say, 25 acids, these compounds separate and travel at different rates, indicating their nature. It's not saponification, but separation. Many people are misinterpreting it as the saponification value," he clarified.He cautions that these sophisticated chromatographic tests can produce false positives due to trace amounts of foreign substances. "With such advanced chromatographic separation, the chance of false positives at these levels is quite high. That's why annexure-1 outlines the conditions under which these false positives might occur," he explained. "These cutting-edge testing methods can be incredibly sensitive, often detecting minute traces that don't necessarily affect the product's overall quality or safety."Furthermore, he elaborated: "Consider this analogy: if someone claimed that breast milk contains pesticides, would you believe it? In reality, pesticides can be present in extremely minute quantities. Sophisticated chromatography tests might detect these trace amounts. Most people would dismiss the idea of pesticides in breast milk. However, if you send a sample to a high-tech laboratory for chromatographic testing, they might detect traces of pesticides, microplastics, or heavy metals. Does this mean breast milk is contaminated? I believe they're essentially taking a minuscule finding and blowing it out of proportion."

Ghee traders weigh in

The Wire also reached out to multiple ghee traders who confirmed that ghee is one of the most adulterated substances. "Ghee is generally mixed with vegetable oils or vanaspati for two reasons." NirbhavDoshi, a former ghee trader from Ahmedabad. told The Wire. "First, they're usually cheaper than animal fats like beef tallow or fish oil. Second, while animal fats might maintain a similar flavour and texture, the aroma is a dead giveaway. Fish oil, in particular, can be easily detected by its distinct smell in the ghee."The Ghee Committee's draft report, submitted to the TTD executive officer in early September and first accessed by news organisation South First, acknowledges sensory testing as crucial for quality control. Humming birds Thrive on an Extreme Life style. Here's How?

brightly coloured blurs that dart about, hovering at and pugnaciously defending their flowers ownership of a feeder.But to the scientists who study them, hummingbirds offer much more than an entertaining spectacle. Their small size and blazing metabolism mean they live life on a knife-edge, sometimes needing to shut down their bodies almost completely just to conserve enough energy to survive the night - or to migrate thousands of miles, at times across open ocean. Their nectarrich diet leads to blood-sugar levels that would put a person in a coma. And their zipping, zooming flight sometimes generates g-forces high enough to make a fighter pilot black out. The more researchers look, the more surprises lurk within those tiny bodies, the smallest in the avian world."They're the only bird in the world that can fly upside down and backwards," says Holly Ernest, a conservation ecologist with the University of Wyoming. "They drink pure sugar and don't die of diabetes."Ernest is one of a small number of researchers studying how hummingbirds cope with the extreme demands of their lifestyles. Here's some of what scientists have learned about the unique adaptations of hummingbirds.

Put in the work

For years, most researchers had assumed that hummingbirds spent only about 30% of their day engaged in the energy-intensive business of flitting from flower to flower and guzzling nectar, while resting most of the other time. But when physiological ecologist Anusha Shankar looked closely, she found they're often working a lot harder than that. Shankar, now of the Tata Institute of Fundamental Research in Hyderabad, India, tried to figure out how broad-billed hummingbirds in Southern Arizona spend their days. Using a mix of experimental methods, she measured the birds' metabolic rate during various activities and estimated their total daily energy expenditure. Adding in previous published data, Shankar was able to calculate the per-minute energy cost of perching, flying and hovering – basically a bird's three options for spending time. She then inferred how much time the birds must have spent feeding versus perching over the course of a day."We ended up finding that it's super variable," Shankar says. During the early part of the summer when flowers are abundant, birds could meet their daily energy needs with as little as a few hours of feeding, spending as

much as 70% of the day just perching, she found. But when flowers became scarcer after the arrival of the summer monsoon rains, birds at one site perched just 20% of the time and used the rest of the day for feeding. "That's 13 hours a day!" Shankar says. "There's no way I can spend 13 hours a day running. I don't know how they do it."

Seriously chill

Hummingbirds have a trick to help them eke out their energy reserves: When a bird is in danger of running out of energy, it may go torpid at night, dropping its body temperature nearly to that of the surrounding air - sometimes just a few degrees above freezing. While in torpor, the bird appears almost comatose, unable to respond guickly to stimuli, and breathing only intermittently. The strategy can save up to 95% of hourly metabolic costs during cold nights, Shankar has calculated. That can be essential after days when a bird has fed less than usual, such as after a thunderstorm. It also helps birds save energy to pack on fat before migration. Shankar is now studying which parts of their physiology hummingbirds prioritize during torpor, by looking to see which gene products they can't do without. "If you're a hummingbird functioning at 10% of your normal metabolism, what is that 10% that's keeping you alive?" she asks.One set of genes that the birds seem to leave untouched are those responsible for their internal clock. "It's important for them to do things at the right time when they're in torpor," Shankar says. To be ready to meet the day, for example, the birds begin to rouse from their torpor about an hour before sunrise, well before visible light cues.

Deal with the sugar

To fuel their sky-high metabolic rate, hummingbirds suck down about 80% of their body weight in nectar each day. That's the equivalent of a 150-pound person drinking nearly a hundred 20-ounce Cokes daily — and nectar is often much sweeter than a soda. The human gut is incapable of absorbing sugar that fast, which is one reason why consuming too much soda or Halloween candy upsets the stomach, says Ken Welch, a comparative physiologist at the University of Toronto at Scarborough. Hummingbirds cope with the onslaught by having leaky guts so that sugars can enter the bloodstream between gut cells instead of only through them. This gets sugar out of the gut quickly, before it can cause upset. That rapid transport, and probably other adaptations as well, allows



hummingbirds to reach blood sugar levels as much as six times higher than those seen in people, Welch says. That much sugar in the blood leads to serious physiological problems in people. It causes more sugar molecules to glom onto body proteins, a process known as glycation; in the long run, excess glycation causes many of the complications of diabetes, such as nerve damage. It's still unclear how hummingbirds avoid the problems of glycation, Welch says, but clues are beginning to emerge. One study, for example, found that bird proteins contain fewer of the amino acids most prone to glycation than mammal proteins, and those that remain are often tucked deep within the protein where they're less exposed to circulating sugars. Other, as yet unknown strategies to cope with high blood sugar may one day yield practical benefits for managing diabetes in people. "There could be a gold mine in the genome of the hummingbird," says Welch

Do a metabolic flip

By the end of its nightly fast, a hummingbird has nearly depleted its sugar stores — which poses an opposite metabolic challenge. "How does it wake up and fly?" Welch asks. "There's nothing but fat available to burn."Hummingbirds have evolved to be remarkably nimble at switching their metabolism from sugar-burning to fat-burning, he has found. "This requires an enormous shift in the biochemical pathways that are involved," Welch says — and it happens in mere minutes, far more quickly than other organisms can manage. "If we could have that kind of control over our fuel use, we'd love that."

Save water - or not

Sugar isn't the only challenge posed by a nectar-rich diet. After all, nectar is mostly water — and birds that drink in so much liquid must get rid of most of it, without losing electrolytes. As a result, hummingbird kidneys are highly adapted to recapture electrolytes before they are excreted. "They pee almost distilled water," says Carlos Martinez del Rio, an ecophysiologist now retired from the University of Wyoming. But that brings a further problem: If a hummingbird kept producing dilute urine overnight, it would die of dehydration before morning. To avoid that, hummingbirds shut down their kidneys every night. "They go into what, in a human, would be considered acute renal failure," says Martinez del Rio. "Hummingbirds have to do this, or they would piss themselves to death."

Fly high – gradually

The metabolic demands on a hummingbird are tough enough at sea level. But many species live at high elevations, where thin air contains less oxygen and offers less resistance to push against when hovering. Consider the giant hummingbird, the world's largest, which can live in the Andes Mountains at elevations over 14,000 feet - higher than many helicopters can fly. To cope with these conditions, the birds have evolved more hemoglobin-rich blood, says Jessie Williamson, an ornithologist at Cornell University.But some of the birds face an even steeper challenge, as Williamson found. Giant hummingbirds are large enough that researchers can attach satellite tracking tags, as well as smaller geolocators. So Williamson and her colleagues decided to fit the birds with trackers. After thousands of hours spent trying to capture birds with netting, the researchers managed to attach trackers to 57 birds using custom-made harnesses of elastic jewelry cord. Though they recovered tracking data from only eight birds, even that tiny sample had a big surprise: Some of the birds lived in the high Andes year-round, while others - which turned out to be a separate, hitherto unrecognised species - migrate to the Andes annually from breeding grounds along the coast of Chile. That means they face not only the obvious challenges of a long migration - a round trip of roughly 5,000 miles - but also the need to adapt to thinner air as they travel. Their secret? Do it gradually. "It looks a lot like how human mountaineers summit something like Mount Everest, with bursts of climbing and pauses to acclimatize," Williamson says. "The journey takes months."As tracking technology becomes lighter and cheaper, researchers like Williamson hope to follow smaller hummingbird species as well. That, together with other progress in research technology, may offer plenty of new surprises about the biology of these tiny, amazing birds.

The story is the hero in the detective drama and it will keep you at the edge of your seat. The climax does come as a shocker. There is an unnerving silence that flows through every scene leaving the audience with a disturbing feeling; with the background score adding the chills.
